The team members will be equipped with smart devices operating on FirstNet that will be preloaded with software that will allow for immediate one-to-one or one-to-many communications, exchange graphical information such as photos, have access to video surveillance cameras, where available, and other resource information. In addition, one of the software solutions that will be preloaded is the ability to have instant communications with what is known and Enhanced Push to Talk (EPTT). This software not only allows for direct push to talk communication, but also provides for end-to-end security, location service, video, graphics such as building schematics and other critical information. This technology will then be connected to the local public safety agencies via "Radio over IP" interconnect boxes installed at the communication center. The specific reason for the use of the first responder network, known as FirstNet, is to insure that this team and network will have priority on a broadband network with preemption. SFY 2019 School Security Disbursement Program funds requested in this application will, if approved, be utilized to provide training, equipment and contractual services for 10 school officials (inclusive of resource officers) per school in the School District from March 1, 2019 through June 30, 2021 to support the school district's efforts in the prevention of entry of unauthorized individuals into the public school facility, to expedite the communications when a threat is present and to provide warning of a threat to critical staff members. This will be accomplished through the establishment of a 10 member crisis management team within each school that will be equipped with smart devices that are FirstNet enabled. These teams will then be provided high-level, in-depth training in all school emergency response plans to include: threat identification, threat assessment, internal/external communications protocols. Each school's team will be provided additional subsequent quarterly refresher training.

***Finally, each school will seek to collaborate with first responder agencies to ensure compatibility and operability of all equipment purchased with these funds.

The service provider will provide initial and ongoing training for each team that will include the following:

- Operation of the smart device
- Use of all software to include enhanced push to talk
- Video system access where available

The school district shall provide initial, and quarterly thereafter, training in the following:

- Applicable policies and procedures related to authorized and unauthorized facility access
- Threat identification
- Threat assessment
- Warning and Communications Protocols

Additionally, the entire school faculty will receive training on the goals and objectives of this team and how to effectively work with and support this team.

Mock exercises will be developed by school officials and will be performed quarterly. All schools will seek to include first responder agencies in all exercise activities.

This software not only allows for direct push to talk communication, but also provides for end-to-end security, location service, video, graphics such as building schematics and other critical information. This technology will then be connected to the local public safety agencies via "Radio over IP" interconnect boxes installed at the communication center. This technology will allow for the complete exchange of critical information at critical times.
